44 months without relying on grant
funding.

About me...

Before working in Local Government, I worked for various accounting firms in Brisbane.

Working for the Department of Local Government, in March 2008, I was appointed Financial Controller for Pormpuraaw Aboriginal Shire Council after the Council received an "unable to form an opinion" result (very bad).

At that time, they had not had an unqualified result (good) for more than ten years, so I worked with the funding body to protect the Council from bankruptcy and finished my role in June 2009.

In May 2010 I came back to the Council as the Finance Manager,

based in Cairns and the Council obtained its first Unqualifed Audit (good) in 2012/13

In 2013 I became the Operations
Manager and relocated to
Pormpuraaw with my husband
David, who became Council's first
Workplace Health and Safety
Officer until the end of 2014.

David and I have twin girls, who are now 29.

In December 2013 the girls came to Pormpuraaw for Christmas.

While they were here Tasmyn had a visit to the Crocodile Farm and she now works at Australia Zoo on the Sunshine Coast.

I have a Bachelor of Accounting and 25 years of experience working in Local Government, mostly with Aboriginal Councils including Kowanyama, Umagico (in the NPA) and Aurukun, and have held CEO roles at Yarrabah and Napranum.

Territory, and in Cunnumulla for the Paroo Shire and, more recently, the Quilpie Shire, both in far far southwestern Queensland.

At the January Ordinary Council meeting, the following things happened:

- Janelle Menzies was formally appointed as Chief Executive Officer and, as she was in the building at the time, ran the meeting from there.
- the December 2024 Quarterly review of the 2024-25 Operational Plan was accepted.
- the financial delegations in the procurement policy for three senior staff were reduced and credit cards were issued for the Mayor and Chief Executive Officer.
- recommendations from the Local
 Government Remuneration Commission
 were set to apply from 1 July 2025. From
 this date remuneration for the Mayor will
 be \$122,975pa, Deputy Mayor \$70,946
 and Councillors \$61,486. These payments
 represent a base payment of \$40,990.67
 plus monthly meeting fees.
- an application for \$100,000 for the Supply Scheme Fund for an upgrade to the Council's Planning Scheme was endorsed.
- a donation of \$28,080 for school lunches at Pormpuraaw State School, funded by contractors working in Pormpuraaw through the Indigenous Economic Opportunity Plan, was endorsed.

Community Services

- An aged Care Quality & Safety Commission audit has been postponed until early 2025.
- The cashier from the main office has been relocated to the Post Office which is working efficiently and effectively.
- Centrelink has been opened for self-service and Council are in the final stages of a recruitment process.
- The SES held a recruitment drive in November 2024 and have signed up six new recruits.
- Council has a new ARNI (ARNI provides essential communications, high-speed data services and greater situational awareness) system which will be operated by the Rangers. (Pictured below)



Corporate Services

- Airport Reporting Officer training will be undertaken in February in Pormpuraaw. The training will be shared with staff from Kowanyama. Staff who undertake the training will participate on the on-call roster.
- Multi-factor authentication for the Council's IT infrastructure access project has been completed.
- The Admin Store undertook a stock take on 29 to 30 January 2025.
- Replacement ablution and laundry units for the Main Roads
 Camp are in Cairns and will be transported when the roads are open again.

The Waterpark is back in use.


